# PRACTICAL INFORMATION

#### **Visa Regulations**

The Office of the Public Protector Zambia is making the necessary arrangements with the immigration authorities in Zambia to facilitate for entry into Zambia .All scanned copies of their passports to delegates are requested to forward ombudsmanzambia@cfi.gov.zm before Thursday 11<sup>th</sup> May 2016 or to the AOMA Secretariat so that a list of delegates may be forwarded to Zambian immigration authorities for clearance .We have taken note that there are some ExCom Members that are required to produce their visa prior to boarding their flights with certain airlines and we would implore them to explore the avenue of obtaining visas from the Zambian embassy in their jurisdiction. As you make your flight bookings also confirm with your travel agents if you may require transit visas en route to Zambia. If not sure about if and how you can obtain visas of if you need a letter of invitation from our host in order to submit your visa application please contact, Mr Kebby Hakalima (ombudsmanzambia@cfi.gov.zm ) and copy in the Commission Secretary. Office of the Public Protector Zambia. Mrs Chipili Katunasa-Magavane (chipili.katunasa@cfi.gov.zm). Visa fees of USD 50 will be payable at the point of entry.

## **Airport Transfer**

Transport will be provided by the Office of the Public Protector, Zambia to ferry delegates from Kenneth Kaunda International Airport to the Hotel/Lodge and back if necessary.
