### **Showcasing Specialised Ombudsman Offices:** Children's Ombudsman

Ombudsman institutions are essential in protecting human rights and promoting accountability. Children's Ombudsman offices focus specifically on safeguarding the rights and welfare of children. These offices ensure that policies, services, and practices affecting children are fair, just, and comply with international human rights standards. Given the unique vulnerabilities faced by children, these specialised Ombudsman offices are critical for addressing issues such as child protection, access to education, healthcare, and social services.

The objective of this webinar is to highlight the role, functions, and best practices of Children's Ombudsman offices. It will serve as a platform for knowledge exchange on how these institutions advocate for children's rights, investigate complaints, and influence policy changes to foster a safer and more equitable environment for children.

Hon. Aneeta GHOORAH, from Educator to Director Education, through Rectorship, Hon. Ghoorah has gradually climbed the ladder and gained experience in all facets of Administration, management, monitoring and evaluation of programmes and projects. Moreover, Mrs Aneeta Ghoorah has been Assistant Secretary /Secretary General of the National Commission UNESCO from 2012 until she retired in January2024. Accordingly, she is very

Mrs Ghoorah worked in close collaboration with the office of the UN Resident Coordinator in her capacity as SG, NatCom UNESCO and with our Embassy in Paris. She has been appointed as Ombudsperson for Children as from February 2024.

**Hon. Stans Goudsmit** is the local children's Ombudsman in Rotterdam, Netherlands. Appointed by the local council in 2018, Stans just started her second term. Stans is also appointed as substitute local Ombudsman. Being a human rights lawyer, protecting children's rights is at the core of her work. Stans is a former member of the Netherlands Institute for Human Rights (2008 – 2017). She focused on improving the rights of people with a disability and on combating discrimination. Before that she was a lawyer at a renowned immigration law office in the Netherlands (1997 – 2007). She was on the supervisory board of Defence for Children - ECPAT Netherlands (2017-2022).





Hon. Commissioner Christina Nomdo was appointed as the Western Cape Commissioner for Children for a five-year term from 1 June 2020. Her mandate is to promote and protect the rights, needs, and interests of children in the Province. The Commissioner is an oversight mechanism for the Department of Education, Health, Social Development, as well as Cultural Affairs and Sport. Christina has worked professionally for over 30 years on issues affecting children's rights. Christina holds a Master's degree from the University of Cape Town. Christina is passionate about children's participation in governance.

Hon. Major General Oswald D Reddy is a certified leadership and life coach, trainer, and teacher with the John Maxwell Team. On 01 October 2021, he was appointed as the 3rd Western Cape Police Ombudsman since the establishment of the office in December 2014. He is a police veteran with over 39 years of experience in various facets of policing and has held the rank of Major General in the South African Police Service for 19 years. He holds a master's degree in Public Administration (MPA) from Harvard University (USA), a Bachelor of Law Degree from the University of South Africa amongst other qualifications.
